Clinect PROs follows the patient throughout their treatment. Care teams receive alerts when thresholds are met and other data in real time.

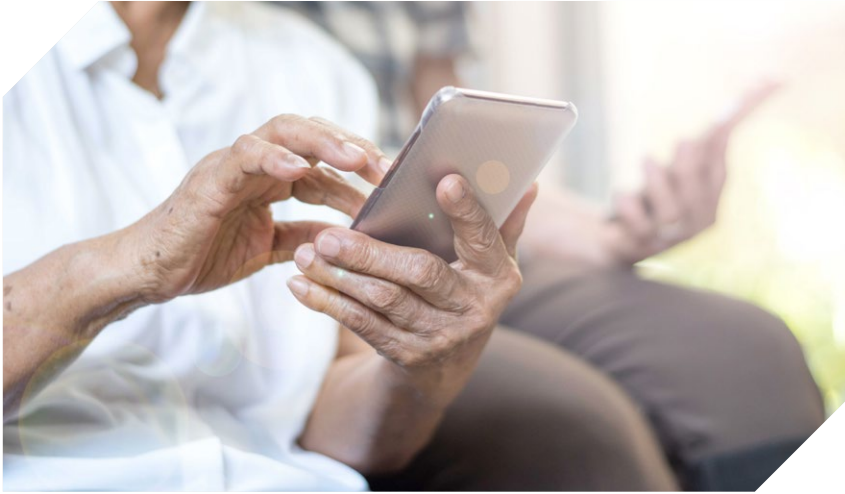
